

The move comes at a time when the government is planning to clamp down on all surrogate advertisements for alcoholic beverages, including event sponsorships, according to a report by Reuters. This sweeping ban, if implemented, will impact all alcohol beverages companies, both domestic and global ones which operate in India through their subsidiaries and make use of surrogate platforms such as water, playing cards, and music fests to advertise their brands.

According to the Reuters report, the consumer affairs ministry may impose fines on businesses as well as ban celebrities who endorse such "deceptive tobacco and alcohol advertisements." The report added that final rules were expected to be issued within a month.

## Govt clears 8 h corridors wort

To generate 44 million person days of employment

FE BUREAU New Delhi, August 2

THE CABINET ON Friday approved eight National High-Speed Road Corridor Projects of 936 km length at a total cost of ₹50,655 crore.

The projects are expected to improve logistics efficiency, reduce congestion, and enhance connectivity across the country.

tivity across the country.
Implementing these projects will generate an estimated 44.2 million person days of direct and indirect employment, the government said in a statement.

The corridor approach has led to the identification of a network of 50,000 km of High-Speed Highway Corridors through a scientific transport study based on GSTN and toll data to support India's transformation into a \$30 trillion economy by 2047, it said.

The 88-km six-lane Agra-Gwalior National High-Speed Corridor will be developed on Build-Operate-Transfer (BOT) mode as a fully access-controlled corridor at an estimated cost of ₹4,613 crore. It will reduce the distance between Agra and Gwalior by 7% and the travel time by 50%, thereby bringing in a substantial reduction in lonistics core.





Nidhi Khare, a secretary at India's Department of Consumer Affairs, has indicated that the final rules regarding this law are expected to be published within a month.

The proposed penalties for violating the draft consumer law include endorsement bans of up to three years and fines up to Rs 5 million (US\$60,000).

If the ban comes into effect, it could significantly impact advertising strategies for major brands like Diageo's Black & White ginger ale, which features symbols associated with the Scotch brand, and Carlsberg's Tuborg drinking water, which shares similarities with its beer advertising.
